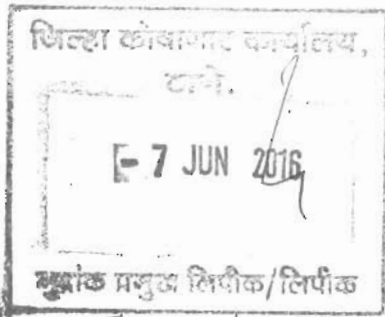

WHEREAS

- A. Both parties are involved in the field of education and share their common interest in academics
- B. The purpose of this MOU is to continue to develop and expand a framework of cooperation between both parties.
- C. The Parties have thought it expedient to lay down the Terms and Conditions in writing as hereinafter to ensure proper implementation in letter and spirit of the intent of this MoU.

IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:


- 1. They may consider certain opportunities of faculty exchange.
- 2. There may be exchange of publications, research materials, newsletters etc.
- 3. Opinions on curriculum development may be sought as and when required by either party.
- 4. Specific initiatives may be considered and agreed upon, on a case by case basis, including the contributions and obligations of each institution. Each such initiative shall be negotiated between and shall have a mutual agreement in writing between both parties.
- 5. This MOU shall remain in effect for a period of three years from the date of execution by both parties. It may be extended or ammended with a written consent from both the parties. Either party, upon thirty (30) days written notice, may terminate the agreement in whole, or in part, at any time before the date of expiration.
- 6. Modifications to this MOU shall be made by mutual consent of the parties, by the issuance of a written modification, signed and dated by authorized officials, prior to any changes being performed.
- 7. This MOU in no way restricts either party from participating in similar activities with other public or private agencies, organizations, and individuals.
- 8. This MOU is not a legally binding agreement. Execution of this MOU shall create no material, financial or any other obligations on either of the parties hereto.
- 9. There would not be any financial liability on either party and if at all any such issue arises, it will be mutually sorted out.


