This Memorandum of Understanding (MoU) sets forth the terms and understanding between Ahmedabad Branch of WIRC of ICAI and Sheth Damodardas School of Commerce, Gujarat University in reference to the Certificate Course of Goods and Services Tax (GST) offered by Sheth Damodardas School of Commerce, Gujarat University. This course will create synergy between University education and Professional education to enhance the employability of the Graduates of Gujarat University.

It also sets forth the respective responsibilities of both parties in relation to the Certificate course arrangements and placement as agreed upon. Both parties to the MoU have agreed to cooperate accordingly to ensure maximum coherence and consistency of providing latest knowledge of GST and the promotion of the consistency of their respective quality assurance roles, policies and procedures, and sustainability in the long-term.

(1) Objectives of this MoU

- (a) The objective of this MoU is to start a Certificate Course on GST
- (b) The Certificate Course on GST will provide knowledge regarding compliance and legal aspects of GST.

(2) Activities Envisaged

- (a) This course will be offered to students who have cleared their under graduation and graduate programmes.
- (b) This course will be offered for duration of two months of 60 hours.
This Certificate Course will be offered twice in an Academic year.
- (c) This course will be offered and managed by Sheth Damodardas School of Commerce, Gujarat University. Infrastructure facilities will be provided by Sheth Damodardas School of Commerce.
- (d) Ahmedabad Branch of WIRC of ICAI will only provide technical collaboration and inputs for the course curriculum. This technical collaboration will be promoted in promos in newspaper and brochure of the Certificate Course.

(d) The examination will be conducted by Sheth Damodardas School of Commerce, Gujarat University at the end of two months duration.

(e) The Certificate of this course will be given by Sheth Damodardas School of Commerce, Gujarat University.

(f) After successful completion of the programme, students will be given placement support by Ahmedabad Branch of WIRC of ICAI to the extent possible.

(g) Ahmedabad Branch of WIRC of ICAI will not bear or will not be responsible for incurring any cost / expenditure for rendition of this course. The sole financial responsibility of the course lies with Sheth Damodardas School of Commerce, Gujarat University.

Termination of Understanding:

This MoU may be terminated by the Ahmedabad Branch of WIRC of ICAI or Gujarat University by giving an advance notice of three months in writing. If a notice of termination is issued either by Ahmedabad Branch of WIRC of ICAI or Gujarat University and the Certificate course is going on or the next course has already been promoted then the ongoing course will be completed and termination of this MoU will not affect the terms of ongoing activities at the time of termination.

This MoU will be effective from the date of signing by authorized representatives of both the organizations.






