One of the functions of the academy is to publish the best literary works and make them available at economical rate. To provide the grant to the colleges, universities & institutes of literature for performing literary activities. To assist the emerging writers, the writer writing literature for children, the translators, new researcher and critics for their publications. Above all Gujarat Sahitya Academy facilitate the best literary figures of all languages.

- Gujarat Sahitya Academy (GSA) and Gujarat University (GU) will jointly organize literature related programmes.
- They shall assist each other in the in the field of research, extention & collebroation activity i.e. local level to state or nation or international level for Gujarati, Hindi, Sanskrit, Sindhi, Urdu and Kachchi literature.
- Gujarat Sahitya Academy shall be permitted to Gujarat University to utilize the creativity of the authors of Gujarat Sahitya Academy for the development of literary activities.

- Apart from all this the Gujarat University shall permit the employees of Gujarat Sahitya Academy to pursue research work as per the PhD RPG of Gujarat University/ UGC/ State Government / respective council on the basis of their educational qualification. If such employees are selected as research guides, Gujarat University will approve their appointments as per current rules and regulations time to time.
- Gujarat University shall provide mutual agreement base facility/primacies for the sale & exhibition of the publication by Gujarat Sahitya Academy. *and Activity centre*
- Gujarat Sahitya Academy shall offer special discount to all the libraries, teacher and Students of Gujarat University.
- Both the institutions will co-operate each other to fulfill their Vision, Mission & Goals endorsed by Gujarat University.
