

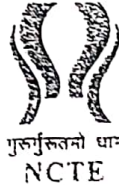

**ORDER**

Whereas, the DEPARTMENT OF EDUCATION, GUJRAT UNIVERSITY, SCHOOL OF PSYCHOLOGY, EDUCATION, & PHILOSOPHY, GUJRAT UNIVERSITY, NAVRANGPURA, AHMEDABAD-380009, GUJARAT (Institution/Society/Trust) has made application to the Western Regional Committee (WRC) of NCTE for recognition of the institution for M.ED. teacher training programme vide Application Code No APW03315/325033 with proposed annual intake of 30 students at AHMEDABAD.

And the WRC, after scrutiny of documents submitted by the institution and the report alongwith the video tapes of the Visiting Team has decided in its 96th meeting held during 13th to 17th April, 2007 to grant conditional recognition/permission for one unit of 30 students as per Regulation 7(11) of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2005.

In pursuance thereof, the institution shall be informed of the decision for grant of unconditional recognition/permission subject to fulfillment of the following conditions:-

- i. Appointment of requisite faculty members/staff having prescribed qualifications and experience are made by the institution on the basis of recommendations of the Selection Committee constituted as per the policy of the UGC/Affiliating University or the State Govt. on such terms and conditions of service as contained in the Regulations applicable for the said teacher training course.
- ii. After appointing requisite faculty members/staff, their particulars with photographs are put on its official website by the institution and the WRC is formally informed alongwith the following documents in proof/support of the same:-
  - a. An affidavit duly attested by the Notary Public on a non-judicial stamp paper of Rs. 100/- from the Institution/Society/Trust (as per the format Annexure-I attached herewith) that requisite qualified faculty members/staff have been appointed on the basis of the recommendations of the Selection Committee constituted as per the policy of the UGC/Affiliating University or the State Govt. on such terms and conditions of service as prescribed by the Regulations, Rules, etc. applicable for the said teacher training course.
  - b. An affidavit duly attested by the Notary Public on a non-judicial stamp paper of Rs. 10/- from every individual faculty member/staff so appointed as per format the Annexure-II attached herewith.

Dear Sir,

Taking cognizance of the shortage of trained teacher educators in teacher education institutions in the country, the National Council for Teacher Education has decided to enhance the intake capacity of one unit of M.Ed. Course from the existing 25 students to 35 students from the current session 2010-11. The enhancement in the intake of M.Ed. programme has been duly notified vide National Council for Teacher Education (Recognition Norms and Procedure) Second Amendment Regulations, 2010 in the Gazette of India on 26<sup>th</sup> July, 2010 and can be accessed on NCTE website ([www.nccte-india.org](http://www.nccte-india.org)). The amended Regulations stipulate that this increase be allowed, without insisting on any corresponding increase in the infrastructure and faculty.

You are, therefore, requested that the intake of students in the approved M.Ed. programme of 25 students may be enhanced to 35 students from the existing session 2010-11 so that a larger number of qualified M.Ed. are available for appointments in the teacher education institutions, in a short time.
