## **Submission Guidelines**

#### **Abstracts:**

There is no streamlined format for the abstract. Authors must identify their chosen sub-theme in their abstracts. Co-authorship is allowed, subject to registration of both and both presence is required.

# **Main Paper:**

- 1. The length of the paper shall not exceed 4500 words, excluding footnotes and the abstract.
- 2. The submission shall be in MS-Word format (.doc or .docx) and must be typed in A4 paper with one inch margin on all the sides.
- 3. Font size shall be Times New Roman 12, with 1.5 spacing. Font size for the footnotes shall be Times New Roman 10, with 1 spacing.
- 4. Bluebook 20th Edition citation shall be followed.
- 5. Only Authors whose abstracts are selected are allowed to present paper.
