**Terms and Conditions for recruitment:**

1. Online applications are invited from Indian nationals for the above positions purely on contractual basis. This shall also include a probation period of the first three months of the tenure. **These positions are co-terminus with the project tenure.**
2. The vacancies for each post is determined based on the requirement of the project.
3. **Age limit: 50 Years as on the last date of application.**
4. The employment may be terminated by the DIA-SVPCoE without notice during the probation period if the performance is not satisfactory. Post probation period, the employment may be terminated by DIA-SVPCoE by providing one month written notice of termination.

6. Eligible candidates may submit their application in the google form available on the website at <https://diasvpcoe.gujaratuniversity.ac.in/Home/recruitment>
7. Copy of the application form received in registered email as acknowledgement along with self-attested certificates of education qualification and experience should bring at the time of interview
8. Only shortlisted candidates will be called for a written test and/or interview.
9. The candidate can apply for multiple positions. However, separate applications need to be submitted for each position by the candidate.
10. Selected candidates will be paid a fixed and consolidated remuneration as mentioned in the recruitment advertisement with standard applicable deductions.
11. Candidates are requested to go through the Application form carefully and provide the information as required. For any query candidate may contact [sc-diasvpcoe@gujaratuniversity.ac.in](mailto:sc-diasvpcoe@gujaratuniversity.ac.in)
12. Candidates should bring all the original required documents at the time of interview for verification. At this stage, if any information is found wrong, candidature will be cancelled.
13. Canvassing in any form may lead to cancellation of candidature.
14. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for the interview. Where the number of applications received in response to an advertisement is large and it is not feasible or convenient to interview all the candidates, the DIA-SVPCoE at its discretion, may restrict the

number of candidates to a reasonable limit based on qualifications / experience higher than the minimum prescribed for the post.

15. Existing employees of DIA-SVPCoE can apply for higher designation provided they have gained more experience or higher qualifications. However, they have to get 'No Objection Certificate' from their respective PIs before applying for the desired designation. Such applications will be considered subject to availability/vacancies for the post/designation applied for.
- 16. The decision of the Selection Committee will be treated as final.**
17. The dates of interviews will be communicated through email to the shortlisted candidates. Any change of correspondence address/ email/ phone from the one given in the application form is not allowed.
- 18. No TA/DA will be paid for attending the interview.**
19. The DIA-SVPCoE shall process the applications entirely based on information/documents submitted by the candidates. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall solely lie with the candidate
20. Suppression of factual information, supply of fake documents, providing false or misleading information or any other undesirable action by the candidate shall lead to the cancellation of his candidature.
21. The Selected candidates need to submit a valid police verification certificate from the most recent place of residence failing which the candidate shall lead to the cancellation of his/her candidature.
22. The selected candidates will have to sign a non-disclosure agreement at the time of joining. Any breach of this agreement will be treated as breach of The Official Secrets Act, 1923 as amended from time to time.
