- 1. All Candidates must remain present 30 minutes before commencement of counseling at venue.
- 2. Candidates are advised not to leave admission premises till instructed by committee. If any candidate leaves the hall, he/she will lose the claim of any seat.
- 3. If candidate is unable to come in person, then authorized person can come with prescribed Authority letter (Annexure IV) and will be considered for counseling.
- 4. The candidate, who remain absent on the scheduled day and time of counseling, will have no right for admission.
- 5. Candidate must have minimum one year of experience after Basic B.Sc. or minimum one year of experience prior or after Post Basic B.Sc. Nursing before the date of first counseling. Candidate should have to <u>produce full</u> <u>one year of valid experience certificate at the time of First Counseling</u>, failing which; candidate will not be eligible for admission.
- 6. The candidate has to pay tuition fees of one term (six months) for Self financed Institutes and Whole Course Tuition fees (as per government order) for Government Institutes and University Fees by cash &/or Demand Draft in favor of "MPT MSC (NURSING) ADM COMMITEE GUJ UNI" Payable at Ahmedabad at bank facility provided by Admission Committee at the place of counseling immediately, otherwise his/her admission will be treated as cancelled. (Candidate must go through the details of Fees attached herewith -Annexure I)

Excess fees, if any paid by the candidate, will be refunded after completion of entire admission process.

- 6. Valid EWS (Economical Weaker Section) certificate issued after 01/04/2022 by competent Authority as prescribed by the Govt. of Gujarat (If Applicable)
- 7. Document showing Place of birth & Date of Birth & Indian Citizenship (School leaving Certificate/ Transfer Certificate/ Birth Certificate)
- 8. Certificate of completion of PG Course (If Applicable),
- 9. Nursing Council Registration Certificate
- 10. Certificate of College recognition by INC (for Students other than Gujarat University)
- 11. For In-service/Employed Candidates- Study leave/Resignation/NOC as per Rule 7.8

Any candidate failed to produce any original document and/or undertaking will not be included for admission process.
- 11. If candidate gets admission in any branch, then the envelope containing all original documents shall be submitted to the Admission Committee.
- 12. If a candidate does not opt for a seat in 1st round of counseling or the candidate join/report OR doesn't join/report at the allotted institute or cancels his admission up to Reshuffling counseling then he will be eligible to participate in Reshuffling counseling with applicable rules of Closure.
- 13. Tentative Seat List will be available on the website of Gujarat University <u>www.gujaratuniversity.ac.in</u> and <u>www.gupgmedadm.org</u> in due course.
- 14. Tentative Tuition Fees Details of all institutes are attached herewith.

If it does not reach to the University within one month from the last date of Joining of reshuffling Counseling/final round of Counseling than one term of Candidate will not be granted and if it is applied later than above time limit than as per date of application of registration, term/terms will not be granted depending upon the date of application.

Students admitted in post graduate course has to submit the topic of Dissertation in the prescribed form duly completed, through the College concerned within nine month from the last date of Joining of reshuffling Counseling/final round of Counseling. If it does not reach to the University within nine month from the last date of Joining of reshuffling Counseling/final round of Counseling than one term of Candidate will not be granted and if it is submitted later than above time limit than as per the date of submission of topic of Dissertation, term/terms will not be granted depending upon the date of submission of topic of Dissertation.

I have also verified my eligibility for appearance at the Entrance examination/Post Graduate Nursing Admission.
