The candidate has to pay tuition fees of one term (six months) by cash &/or Demand Draft in favor of "MPT MSC (NURSING) ADM COMMITEE GUJ UNI" Payable at Ahmedabad at bank facility provided by Admission Committee at the place of counseling immediately otherwise candidate will not be eligible for admission.(Candidate must go through the details of Fees attached herewith Annexure I)

Excess fees, if any, will be refunded at the end of entire admission process.

- 9. Those candidates who have been allotted seat; they have to submit their original documents in following sequence.

 - 3. Internship Completion Certificate,
 - 4. For SEBC, ST and SC Category: Caste certificate issued by Competent Authorities of Gujarat State only,
 - 5. For SEBC Category: Non Creamy layer Certificate of financial year pertaining to the period of application from the competent authority as prescribed by the Govt. of Gujarat.

- 6. Certificate belonging to Economically Weaker Sections (EWS) issued by the authority empowered by the Government of Gujarat.
- 7. Document showing place of birth & Date of Birth & Indian Citizenship (School leaving Certificate/ Transfer Certificate/ Birth Certificate)
- 8. Certificate of completion of PG Course (If Applicable),
- 9. For In-service Candidates- study leave/resignation/NOC as per rule 7.8 10. Undertaking as per rule no 7.13 of post graduate counselling.
- 10. Candidates should bring envelope of **11x15** inch (or **Sufficient**) size for keeping Original Documents. Write the details on envelope with marker pen as per **Annexure III**

- 13.If a candidate does not opt for a seat in 1st round of counselling or the candidate join /report OR doesn't join/report at the allotted institute or cancels his admission before Reshuffling Counselling then he will be eligible to participate in Reshuffling counselling.

- 15.All candidates have to submit the undertaking attached herewith as per rule 7.13 of Post graduate admission at the time of Counselling failing which candidate will not be considered for counselling.
- 16.Candidate must join / report to the allotted college on or before 30/06/2022 up to 3 PM, otherwise his/her admission will be treated as cancelled and he/she cannot claim the same seat in future/further round of admission.

If it does not reach to the University within one month from the last date of Joining of reshuffling counselling/final round of counselling than one term of Candidate will not be granted and if it is applied later than above time limit than as per date of application of registration, term/terms will not be granted depending upon the date of application of Registration.

Students admitted in post graduate course has to submit the topic of Dissertation in the prescribed form duly completed, through the College concerned within three month from the last date of Joining of reshuffling counselling/final round of counselling. If it does not reach to the University within three month from the last date of Joining of reshuffling counselling/final round of counselling than one term of Candidate will not be granted and if it is submitted later than above time limit than as per the date of submission of topic of Dissertation, term/terms will not be granted depending upon the date of submission of topic of Dissertation.

I have also verified my eligibility for appearance at the Entrance examination/Post Graduate Optometry Admission.
