- 1. All Candidates must remain present 30 minutes before commencement of counseling at venue.
- 2. Candidates are advised not to leave admission premises till instructed by committee. If any candidate leaves the hall, he/she will lose the claim of any seat.
- 3. If candidate is unable to come in person then authorized person can come with proper Authority letter (Annexure IV) and will be considered for counseling.
- 4. The candidates should wear a Face mask and follow Covid appropriate behavior in admission hall.
- 5. The candidate, who remains absent on the scheduled day and time of counseling, will have no right for admission.
- 6. The candidates must have completed Internship before the date of first counseling. Candidate must <u>produce full Internship Completion</u> <u>Certificate (issued by College or University) at the time of First Counseling</u>, failing which, candidate will not be eligible for admission.
- 7. The candidate has to pay tuition fees of one term (six months) for Self financed Institutes and Whole Course Tuition fees (as per government order) for Government Institutes and University Fees by cash &/or Demand Draft in favor of "MPT MSC (NURSING) ADM COMMITEE GUJ UNI" Payable at Ahmedabad at bank facility provided by Admission Committee at the place of counseling immediately, otherwise candidate will not be eligible for admission.(Candidate must go through the details of Fees attached herewith Annexure I)

Excess fees, if any, will be refunded at the end of entire admission process.

- 9. Those candidates who are allotted seat have to submit their original documents in following sequence.

 - 3. Internship Completion Certificate,
 - 4. For SEBC, ST and SC Category: Caste certificate issued by Competent authorities of Gujarat State only.
 - 5. For SEBC Category: Non Creamy layer Certificate of financial year pertaining to the period of application from the competent authority as prescribed by the Govt. of Gujarat.
 - 6. Certificate belonging to Economically Weaker Sections (EWS) issued by the authority empowered by the Government of Gujarat issued on or after 01/04/2019. (If Applicable)

- 7. Document showing place of birth & Date of Birth & Indian Citizenship (School leaving Certificate/ Transfer Certificate/ Birth Certificate)
- 8. Certificate of completion of PG Course (If Applicable),
- 9. For In-service/Employed Candidates- Study leave/resignation/NOC as per rule 7.8
- 10.Undertaking as per rule no 7.13 of post graduate counselling. (Attached herewith)
- 10.Candidates should bring envelope of **11x15 inch (or Sufficient)** size for keeping Original Documents. Write the details on envelope with marker pen as per <u>Annexure III</u>
- 11. Verification of all the original documents and undertaking attached herewith as per rule 7.13 of Post graduate admission will be done before counseling. Any candidate failed to produce any original document/undertaking will not be included for admission process.

- 13. If a candidate does not opt for a seat in 1st round of counselling or the candidate join /report OR doesn't join/report at the allotted institute or cancels his admission before Reshuffling counselling then he will be eligible to participate in Reshuffling counselling.

- 15. Tentative Tuition Fee details of all institutes is attached herewith.
- 16. All candidates have to submit the undertaking attached herewith as per rule7.13 of Post graduate admission at the time of Counselling failing which candidate will not be considered for counselling.
- 17. Candidate must join / report to the allotted college on or before 30/06/2022 up to 3 PM, otherwise his/her admission will be treated as cancelled and he/she cannot claim the same seat in future/further round of admission.

If it does not reach to the University within one month from the last date of Joining of reshuffling counselling/final round of counselling than one term of Candidate will not be granted and if it is applied later than above time limit than as per date of application of registration, term/terms will not be granted depending upon the date of application.

Students admitted in post graduate course has to submit the topic of Dissertation in the prescribed form duly completed, through the College concerned within three month from the last date of Joining of reshuffling counselling/final round of counselling. If it does not reach to the University within three month from the last date of Joining of reshuffling counselling/final round of counselling than one term of Candidate will not be granted and if it is submitted later than above time limit than as per the date of submission of topic of Dissertation, term/terms will not be granted depending upon the date of submission of topic of Dissertation.

I have also verified my eligibility for appearance at the Entrance examination/Post Graduate Physiotherapy Admission.
