The candidate has to pay tuition fees of one term (six months) for Self financed Institutes and Whole Course Tuition fees (as per government order) for Government Institutes and University Fees by Cash &/or Demand Draft in favor of "MPT MSC (NURSING) ADM COMMITEE GUJ UNI" Payable at Ahmedabad at bank facility provided by Admission Committee at the place of counseling immediately, otherwise candidate will not be eligible for admission.(Candidate must go through the details of Fees attached herewith Annexure I)

Students admitted in post graduate course has to submit the topic of Dissertation in the prescribed form duly completed, through the College concerned within three month from the last date of Joining of reshuffling counseling/final round of counseling. If it does not reach to the University within three month from the last date of Joining of reshuffling counseling/final round of counseling than one term of Candidate will not be granted and if it is submitted later than above time limit than as per the date of submission of topic of Dissertation, term/terms will not be granted depending upon the date of submission of topic of Dissertation.
