### **Admission for Vacant Seats after Two Online Rounds of MBA courses for Academic Year 2024-25**

The Vacant seats will be filled as per provisions of Rule-18 of prevailing notification for admission. Accordingly aspiring candidates fulfilling eligibility criteria of notification for admission to MBA/MCA courses dated 24.06.2020 & 23.06.2020 respectively issued by Education department, Government of Gujarat shall have to contact Department of Public Policy and Governance between 02.09.2024(from 4:00PM onwards) to 06.09.2024 as per the counselling schedule declared by Department of Public Policy and Governance, B. K. School of Professional and Management Studies for vacant seats admission process at the institute of his/her choice and preference. The candidate has to submit his/her application with all requisite documents and an application fee of Rs.500/- (Only from those who are not in merit of ACPC)at the concerned institution within the prescribed time limit.

#### **Rule for Admission:**

The Merit list will be based on the following priority.

- (i) Final decision will be in the hands of Institute and ACPC only
- (ii) Registered candidates having merit rank given by ACPC of 2024,
- (iii) Not registered for ACPC counselling but appeared for CMAT 2024 based on obtained CMAT marks/score and
- (iv) All eligible aspiring candidates who have passed the qualifying Graduation exam with minimum eligibility criteria as prescribed in rule 5 of prevailing admission notification, but have neither qualified CMAT for the current year.
- (v) Final decision will be in the hands of Institute and ACPC only
