RULES RELATING TO THE RECOGNITION OF PERSONS AS A RECOGNISED UNIVERSITY TEACHER FOR MEDICAL DEGREES AND DIPLOMAS

O. 65-C:

Every application for recognition as a teacher of the University shall be made in writing in the from, provided for the purpose by the University, and shall be submitted through the Head of the affiliated college or recognised institution in which the applicant is working.

O. 65-D:

The Head of the affiliated college or recognised institution, through whom the application is submitted, and the applicant shall give such further information as may be required in connection with the application of the candidate for recognition as a teacher of the University.

O. 65-E:

Every recognised teacher must be attached to an affiliated college or a recognised institution, and his recognition will continue so long as he answers the designation on the basis of which he was recognised.

RECOGNITION OF POST-GRADUATE TEACHERS IN THE SUBJECTS OF MEDICINE, SURGERY & DENTAL SURGERY

O. 65-K:

Recognition of P.G. Teacher in Medical Faculty as follow:

(a) A clinical department or its unit training candidates for broad or super specialities, shall have a minimum of three full time faculty members belonging to the concerned disciplines of whom one shall be a professor, one Associate Professor/Reader and one Assistant Professor/Lecturer, possessing the qualifications and experience for prescribed by the Medical Council of India:

Provided that the second or subsequent additional unit may be headed by an Associate Professor.

Of these faculty members only those who posses a total of eight years teaching experience, out of which atleast five years teaching experience as Assistant Professor/Lecturer gained after obtaining post-graduate degree, shall be recognised as Post-graduate Teachers.

(b) In each department training candidates for super Specialities, there shall be a minimum of three Faculty Members with requisite post-graduate qualification and experience - one professor, one Associate Professor/Reader and one Assistant Professor/Lecturer, with at least two of them holding the degrees of D.M./M.Ch. in the concerned displine. Of these faculty members only those who posses eight years teaching experience out of which at least five years teaching experience as Assistant Professor/Lecturer gained after obtaining the higher speciality degree shall be recognised as post-graduate teacher:

Provided that in the case of super speciality courses which are being newly instituted relaxation of qualification and experience of Post-graduate teachers may be granted by the Medical Council of India for sufficient causes.

Recognition of Teachers for the M.D.S. Degree

O. 65-K(b):

Teachers to be recognised for:

- (a) For various Dental specilities prescribed under R. 260 for M.D.S. Degree must have post-graduate qualifications in the Dental subjects and 5 years' of teaching experience in the subject concerned to the under-graduate Dental classes as a Professor, Assistant Professor or equivalent post in a recognised Dental College, and
- (b) Published at least one research paper independently in a recognised journal.

Notwithstanding anything contained above, those teachers who have already been recognised as post-graduate teachers on or before 14th June, 1973 shall continue to be recognised as Post-graduate teachers in their respective subject for a period of 5 years' during which period such teachers

shall be required as a condition for further renewal of their recognition to have published indepently at least one research paper of recognised merit in the subject in which recognition is sought provided that such independent published research work is other than the thesis dissertation submitted by the teacher concerned for his post-graduate degree.

Note.— In order to confirm the research paper is published in a recognised journal or not, the matter should be referred to the Dean of the Faculty.

O. 65-N:

Period of Recognition

(1) The recognition granted under the foregoing Ordinances shall be for a period of five years.

Renewal of recognition

(2) Each recognised teacher or assistant recognised teacher shall submit at least six months prior to the date on which his recognition expires, a report of all work done by him during the period of his recognition, to the Board of University Teaching and Research.

(Note.— Such reports may include the synopsis of the lectures delivered, the changes be made for the presentation and in the material of his lectures, the difficulties in following the subject that the students experience according to his assessment, the types of tutorials, he conducted, the response he had at these tutorials, the interest he displayed in the extra curricular and other activities, the reading, the writing and the reviewing of books of papers in his subject that he did, and the research work, if any, that he did himself or he guided during the period.

- (3) The Board of University Teaching and Research shall, after considering the report, recommend to the Executive Council whether his recognition be continued further.
- (4) The Executive Council may, at any time, on the recommendation of the Board of University Teaching and Research, withdraw the recognition of a recognised teacher.
- (5) The names of persons recognised as University teachers, whose services have been transferred from one college to another or who have been transferred from one post to another in the same college will continue on the list of University teachers for a period of four months, in order to allow a fresh application for recognition to be considered.

Explanation— This period of four months will not include the period of University vacation.

shall be required as a condition for further renewal of their recognition to have published indepently at least one research paper of recognised merit in the subject in which recognition is sought provided that such independent published research work is other than the thesis dissertation submitted by the teacher concerned for his post-graduate degree.

Note.— In order to confirm the research paper is published in a recognised journal or not, the matter should be referred to the Dean of the Faculty.

O. 65-N:

Period of Recognition

(1) The recognition granted under the foregoing Ordinances shall be for a period of five years.

Renewal of recognition

(2) Each recognised teacher or assistant recognised teacher shall submit at least six months prior to the date on which his recognition expires, a report of all work done by him during the period of his recognition, to the Board of University Teaching and Research.

(Note.— Such reports may include the synopsis of the lectures delivered, the changes be made for the presentation and in the material of his lectures, the difficulties in following the subject that the students experience according to his assessment, the types of tutorials, he conducted, the response he had at these tutorials, the interest he displayed in the extra curricular and other activities, the reading, the writing and the reviewing of books of papers in his subject that he did, and the research work, if any, that he did himself or he guided during the period.

- (3) The Board of University Teaching and Research shall, after considering the report, recommend to the Executive Council whether his recognition be continued further.
- (4) The Executive Council may, at any time, on the recommendation of the Board of University Teaching and Research, withdraw the recognition of a recognised teacher.
- (5) The names of persons recognised as University teachers, whose services have been transferred from one college to another or who have been transferred from one post to another in the same college will continue on the list of University teachers for a period of four months, in order to allow a fresh application for recognition to be considered.

Explanation— This period of four months will not include the period of University vacation.
