## Most Important Instruction for Candidates

- Candidates are advised to contact concern Subject Department at Gujarat University for subject related and others query.
- Candidate who is applying for Ph.D. in multi/inter/intra disciplinary subject has to appear and pass entrance test in the subject in which he/she wants to take admission in Ph.D. For eligibility, see the subject eligibility list on the website.
- Candidate has to present Hall Ticket and his/her valid Photo Identity card at the time of examination.
- All questions are MCQs, total 100 (1-50 Research Methodology/General Analytical Skill/Mental Ability/Reasoning & English Communication, 51-100 Subject specific). No negative Marking.
- Candidate must return back the OMR (Answer Sheet) and Question/Test Booklet to Invigilator after completing Exam and before Leaving Examination Hall.
- No students will be allowed to take Question/Test Booklet with them after examination in any circumstances. Otherwise it is considered as disqualified.

Candidate must keep ready the Print of duly filled Online Registration Form (Application Form) along with Original & copies of following Documents. You need to submit as and when it is asked or at time of PI/VV:

- 1. Mark sheets of Bachelor degree.
- 2. Master degree (Indicating Subject as well as percentage of Marks without rounding & Gracing Marks/Procedure). (Candidates passed from a University where Mark-Sheet does not distinguish grace marks, must submit Certificate about %/Marks/Grade without rounding off & Gracing Marks Procedure.
- **3.** Caste Certificate in Case of Reserved Category (SC/ST/SEBC/EWS) issued by competent Authority of Gujarat State Government. (i.e. FY: 2025-2026)
- 4. Non-Creamy Layer Certificate (For Education-Gujarati Version) issued by the competent authority of Gujarat State Government for valid period (i.e. FY: 2025-2026), (in Case of SEBC).
- 5. *PH Physically Disability Certificate issued by the competent authority (RMO/CMO) of Government Hospital (If applicable).*
- 6. Provisional Eligibility Certificate issued by Gujarat University for Candidates of Other University of Gujarat State/Other States must at the time of reporting for Admission.
- 8. No Telephonic/ Electronic Reporting will be entertained in any case.
