All the bidders should take note of the following **FIVE** corrections for the above tender:

- [A]** Clause Number **1.0 Tender Notification:** on Page Number 3 is **modified** and should be read as follows:

- [B]** Clause Number **3.15 Performance Bank Guarantee:** on Page Number 8 is **modified** and should be read as follows:

**3.15 Performance Bank Guarantee:**

The bidder who is awarded with the order is required to submit, a performance bank guarantee, from a Nationalized/Private Bank, equivalent in Indian rupees for **5%** of the value of order. The bank guarantee will have to be given at the time of acceptance of the offer and it will be valid for the period till **5 Years** after the completion certificate of successful installation is issued by the University.

- [C]** Clause Number **4.5 Server and NAS storage:** on Page Number 9 is **modified** and should be read as follows:

**4.5 Server and NAS storage**

The quantities mentioned in the tender document are tentative and approximate only and shall be used for price comparison purpose.

The Bidder/OEM must note that entire product and ALL its components must be completely factory integrated.

[D] Clause Number **4.6 Product Warranty and support:** on Page Number 9 is **modified** and should be read as follows:

**4.6 Product Warranty and support:**

The Bidder/OEM will have to provide a letter confirming minimum of **5-Years** comprehensive ON-SITE product repair/replacement warranty (Hardware, including Batteries, Software & Upgrades) and provide product support there after.

The Bidder/OEM must note that the University will retain the faulty Disk of Server/Storage after replacement under this warranty.

[E] Clause Number **5.3.2 Hardware :: Network Attached Storage - Sr. No. 3** on Page Number 14 is **modified** and should be read as follows:
