1.0 Details of tender and work as per tender notice.

Instructions and Conditions:

- (1) Working method shall be as per PWD manual, B-1 tender form clauses and standard specifications of R & B.D. will apply.
- (2) Time limit of completion of works is three months from the date of work order.
- (3) If the work will not be completed due to cause of agency within time limit then penalty of Rs. 500 per day shall be levied.
- (4) The registrar of GU does not bind himself to accept the lowest or any tender or to give any reasons for the decision. He is having the right to accept or to reject any or all the tenders without giving reasons.
- (5) The notice of tender, terms and conditions of memorandum and schedule B shall form the part of the contract of document
- (6) The contractor/agency will have to enter into agreement on stamp paper of Rs. 100 whose offer is accepted.
- (7) Rates to be quoted shall be inclusive of all royalties, GST tax, toll tax, local tax, development charges, welfare cess and any other taxes including works contract tax etc. and also any statutory variance in future towards above mentioned taxes and any other taxes if levied in future by statutory authority applicable to this contract shall be borne by the contractor and GU shall not entertain any claim whatsoever in this respect. If quality control tests are required then it shall be done at the cost of contractor for which no extra payment shall be paid by university.
- (8) Warranty/defect liability period: S.D. will be refunded after the expiry of 24 months of completion of work or passing of two monsoons whichever is later.
- (9) Copy of all the original bills of purchase of cement and consumption register shall be produced by the contractor.
- (10) Offer will remain valid for forty five days.
