Gujarat University decision will be final in all matters. Following are the criteria to be fulfilled by interested organization for running the department.

#### **Eligibility Criteria for the bidder:**

1. The Bidder submitting the offers should be a Registered Company firm and should have been in existence for a period of at least 5 years as of 31.03.2021. Bidder should submit proof of its existence.
2. The bidder should have minimum annual average minimum turnover of Rs. 3 Crores or more from IELTS training business and student visa in the last three years ending 31st March 2021.
3. Bidder must have experience of providing training for International English Language Testing System (IELTS).
4. The bidders who are test registration partner of IDP IELTS for registration of the exam date for International English Language Testing System (IELTS) are preferred.
5. The bidder should have at-least 5 full time Cambridge / British Council / IDP TKT trained and certified faculty who should have exposure in imparting English proficiency training for IELTS. An undertaking along with details of qualification & experience of the faculties shall be submitted by bidder. Bidder should have at-least two full-time counsellors certified with any international counsellor certification bodies like CCEA, PIER (QEAC), Study-Uk, USATC (or AIRC) etc.
6. Bidder should have Registered Office based in Gujarat.
7. Bidder can submit any one additional document which can build the credibility of a bidder to be considered by the review committee.
8. Bidder should not be under a declaration of ineligibility for corrupt and fraudulent practices issued by Government of Gujarat or any of the PSU in the state of Gujarat at the time of bidding. (Certificate / affidavit mentioning that the Bidder is not blacklisted by Government of Gujarat or any of the PSUs in the state of Gujarat due to engagement in any corrupt and fraudulent practices).
